Monday 5 November 2012

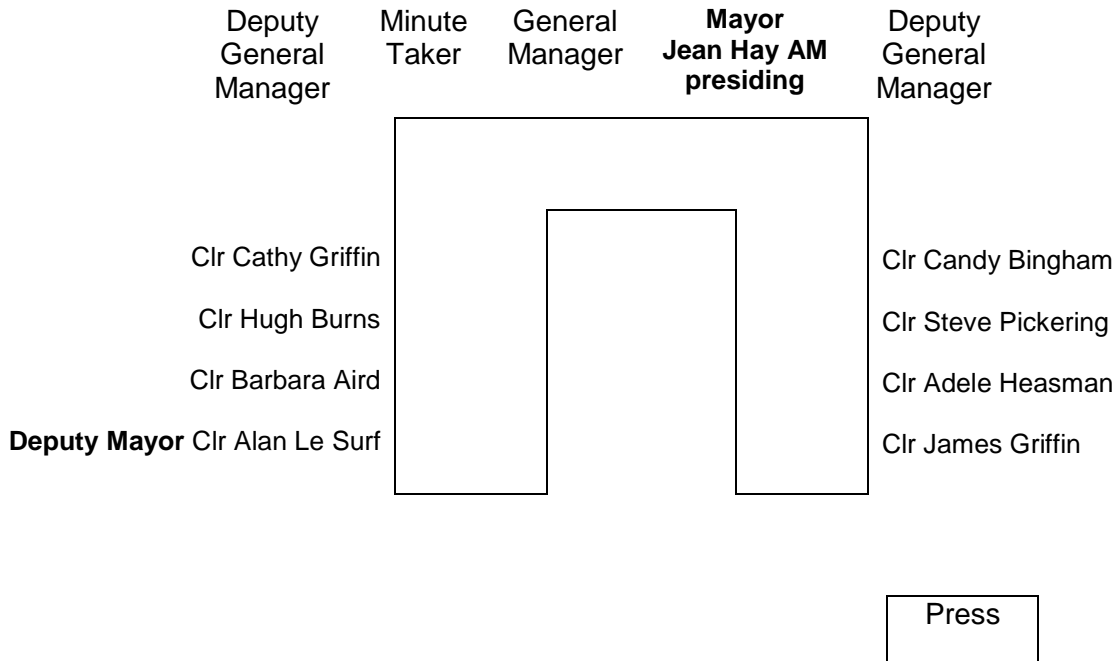
Commencing at 7.30 for the purpose of considering items included on the Agenda.

SUBJECT: Rescission Motion

Councillor Aird, Councillor Burns, and Councillor C Griffin will move:

“That the Council's decision of 15 October 2012 being Mayor Minute Report No 10 in respect of **Free third hour for Residents and Ratepayers parking in Council Car parks** be and is hereby rescinded.”

The resolution passed on 15 October 2012 was in the terms of:

That:

1. the General Manager takes administrative steps to implement a system and scheme that permits each bonafide Manly residential household and ratepayer up to 3 continuous hours per day of free parking at Council's CBD carparks, and
2. the scheme to commence as soon as possible but by no later than the 3rd December 2012.

If the above Notice of Rescission Motion is carried, it is proposed to move the following alternate motion:

That the proposal to implement a system that allows residents and ratepayers up to 3 continuous hours per day of free parking at Council's CBD carparks be deferred until:

1. Council brings back a comprehensive formal report on the proposal. The report to also include the financial impact on the proposed Manly 2015 underground car park, including expected payback period on the loan and identify any additional financial risk to council.
2. Council surveys all businesses within the CBD, particularly raising the issue of turnover of car parking spaces.
3. Council provides a comprehensive implementation plan with true costs of issuing car park cards, the policy on number of cards per ratepayer and resident, and daily re-entry policy and plan to prevent "black market" usage of cards.
4. Council undertakes proper survey (instead of estimates) to ascertain accurate resident/ratepayer patrons staying for 3rd hour in car parks on both week day and weekend (separate figures).

RECOMMENDATION

That the above Notice of Rescission be submitted for consideration.
